### Notice for Updating Social Category for Applicants of Allied Healthcare Courses – 2025 Session


In Compliance with an advisory issued by the Higher Education Department, Government of West Bengal on 30.07.2025, students appeared in SMFWBEE-2025 are hereby informed that they may update their Social Category details prior to publication of result & Merit List.

In view of the above and in the interest of fairness and parity, the State Medical Faculty of West Bengal (SMFWB) has decided to extend a one-time opportunity for all applicants who have applied for admission for Allied Healthcare Courses for the 2025 session and appeared in SMFWBEE-2025, to update their social category, if required.

#### Important Instructions:

1. This is only for applicants who have already applied for and appeared in the SMFWBEE-2025 examination.
2. The online portal will be opened for updates from **17<sup>th</sup> September 2025, to 18<sup>th</sup> September 2025** (up to 11.59 PM).
3. The Candidate must have valid documentary proof to support their updated category. This evidence will be required at the time of correction and again during the verification process.
4. No request for category change will be entertained after the above deadline, under any circumstances.
5. The Candidates claiming OBC category should furnish a declaration in the non-judicial stamp Paper as per proforma annexed herewith, without which no claim would be entertained.

3. I do hereby declare that I shall be bound by the dictum to be  
pronounced by the Hon'ble Apex Court regarding  
implementation of West Bengal Backward Classes, (Other than  
SC and ST).



4. I further declare that I shall not be prejudiced if State Medical Faculty take any coercive measures against me belonging to OBC category in terms of the resultant of the order to be passed by Hon'ble Supreme Court in Special Leave to Appeal being SLP (CIVIL) 17422 / 2025 (The State of West Bengal Vs Purabi Das and Ors.).
5. I further declare that I shall indemnify State Medical Faculty if State of West Bengal modify and/or alter any notification in respect of "Other Backward Class" [O.B.C.] *reservations*.
6. This DECLARATION is an act of equity, fair play and bona-fide acts.
